Subject: HFR Pond and Fishing Rules

Hi Darren,

While fishing on any pond in HFR you must comply with all state and federal rules and regulations and have a license and ID with you at all times unless you are exempt from having one by age etc.

HFR is strictly a catch and release fishery, no exceptions !

You are only allowed to fish with artificial lures having barbless hooks in all HFR ponds.

Fishing with Live Bait is NEVER allowed !!! (for HFR purposes any baits, soft, plastic or dead etc. fished on a stationary bobber are considered live bait and cannot be used)

HFR ponds are for the use of homeowners, lot owners, their families and guests only. Guests who are fishing must be accompanied by the homeowner or lot owner whom they are visiting.

If you see anyone breaking or ignoring the rules please contact the HOA or our management company as these fish are stocked as a resource for our community.

There are no boats or watercraft allowed on HFR ponds. The only time you should see any type of watercraft on one of our ponds is when water levels (depths) are being checked for Fire Department accountability.

Swimming in any HFR pond is strictly prohibited.

We also ask that if you bring food and drink to the ponds or any other community common areas that you please be responsible and take the trash with you when you leave. Trash cans are not provided in these areas so we do not create nuisance animal problems.

Note:

Creating a barbless hook on any artificial lure is easy. Using a pair of needle nose or other small plier, gently crimp the barb flat against the hook and for all practical

purposes you now have a barbless hook suitable for use in most Colorado fisheries.
